2. BOUAMI MAROUANE, student number 1835510121, who didn't apply for resumption within the time limit prescribed by the university after the suspension of school status expires.

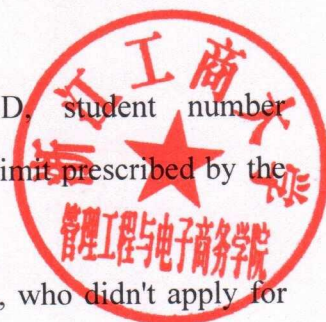

Chapter 8 Academic Warning and Withdrawal

Article 29 International students who fall under any of the following circumstances shall be expelled from the University:

(5) Failing to apply for resumption within the time limit prescribed by the university after the suspension or retention of school status expires, or failing to pass the re-examination of the resumption application.
